1. Issue of 1,075,500 Options with an exercise price of \$1.47. The Options will vest over a four-year period with one-quarter of the number of Total Options granted above vesting annually, on each one-year anniversary of the Date of Grant, with an expiry date for all Options of 4 November 2023.
 2. Issue of 57,000 Performance Rights with an exercise price of nil and the following vesting conditions:
 - Subject to the Participant's continuous employment with the Company or its subsidiaries the Performance Rights will vest on the third anniversary of the Date of Grant to the extent that the performance hurdles are satisfied at the end of the three-year performance period. The extent to which a Performance Condition is satisfied will be determined by the Remuneration Committee, whose decision is final and binding on the Participant. The Remuneration Committee may determine that a Performance Condition has been satisfied at or between "Minimum" and "Maximum", in which case the percentage of Performance Rights that vest will be determined by the Remuneration Committee.
 - The Board may declare that some, none or all outstanding unvested Performance Rights are free of Performance Conditions and may vest on an accelerated basis immediately before a Change of Control Event.
 - If the Participant ceases employment with the Company or its subsidiaries where such cessation of employment is due to death, permanent illness, or permanent physical or mental incapacity, the Performance Rights will fully vest on the third anniversary of the Date of Grant.
